Hello Bradley,

I note that the Council considers that a realistic estimate for the likely duration of the Hearings will be 8 days. It is likely that a Pre-Hearing Meeting may not therefore be necessary. I suggest that the hearings are held on 4 consecutive days Tuesday - Friday for two weeks. It may be prudent to provisionally book the following Tuesday to accommodate any sessions that overrun.

I note the preferred dates suggested by the Council (28 January - 15 Feb). I would like the hearings to commence on 29 January. Could you please confirm that these dates are still acceptable to the Council and check the availability of the venue.

The Council will need to provide you with a dedicated web-page on the Council's web site which should include your contact details, my name, the date and venue for the hearings, a list of core documents, copies of the representations, and any other material produced by the Council, representors, myself or yourself as Programme Officer.
