Heath Lane – remove/ cut down over hanging trees on footpath. Side out walkway. Clear 17 gully tops.  
A448 – Parish Room. Cut away overgrowth from walkway from Parish Room turning junction onto A448.  
Stanklyn Lane – side out walkway  
Dunclent Lane – dig out 2 side grips.  
Stanklyn Lane – side out walkway, cut overgrowth away from footpath either side of railway bridge. Clear 3 grips/3 gullies before bend, outfall into wood 3 grips/2 gullies.  
Butts Lane – Clear 4 gullies  
Witch Lane – Clear 8 gullies and 6 grips.  
Stanklyn Lane – Channel inlet and gully top on Heath Lane junction. Clear 10 grips from Heath Lane junction towards Summerfield.

(c) Parish Footpaths

Branch has fallen off a tree and is blocking the footpath on FP500 approx.350 yards north-east of Dunclett House.

Foothpaths FP 526/530 leading through Fenny Rough are very overgrown and need substantial clearing.
