Wyre Forest Habitat Regulations Assessment Screening Report

1) INTRODUCTION

This Habitat Regulations Assessment (HRA) screening report is intended to identify European sites which could possibly be affected by the Wyre Forest District Local Plan Review. The emerging Local Plan Review has been through a number of stages of consultation as follows:-

- Issues and Options: 6 week public consultation which closed on 16th October 2015
- Preferred Options: 8 week public consultation which closed on 14th August 2017.

All representations received for the Issues and Options consultation were reported to Members and were used to develop the Preferred Options document. We are currently in the process of reporting to Members the consultation responses received for the Preferred Options document. These consultation responses are being used to help inform the emerging Pre-Submission document which will be published for a six week consultation period in Summer/Autumn 2018.

An Appropriate Assessment Screening Report was prepared and underwent consultation with Natural England, Worcestershire Wildlife Trust and the Environment Agency in September 2009 for the currently adopted Core Strategy (adopted December 2010). For the adopted Core Strategy, it was concluded that no further Appropriate Assessment work was required.

It is now necessary to undertake a new Habitat Regulation Assessment screening report for the Local Plan Review (hereafter referred to as the emerging Local Plan). The previous screening assessment was also undertaken before the NPPF was published in March 2012, so the new screening assessment will need to follow post NPPF requirements.

2) BACKGROUND TO HABITAT REGULATIONS ASSESSMENT

This report presents the analysis and findings of the screening stage of a Habitat Regulations Assessment for the emerging Wyre Forest District Local Plan Review.

The EU Habitats Directive [92/43/EEC] on the Conservation of Natural Habitats and Wild Flora and Fauna institutes a legislative framework for the protection of European sites. European Sites are designated to protect areas of important and valuable habitat, or species of flora, fauna and birds which are rare or threatened in a European context. European sites include Special Areas of Conservation (SAC) and Special Protection Areas (SPA). HRA is also required, as a matter of UK Government policy, for potential SPAs (pSPA), and candidate SACs (cSAC) for the purposes of considering plans and projects, which may affect them. This network of SPA and SAC sites is known collectively as Natura 2000 or European sites. Hereafter, all the above-designated nature conservation sites are referred to as 'European sites'. Additionally, despite not being included in the Natura 2000 network of sites, Ramsar Sites are covered by the Directive, and are therefore also included in this screening assessment and referred to under the term 'European sites'. Ramsar sites are listed Wetlands of European Importance.

The requirement for a Habitat Regulations Assessment of strategic land use plans, policies and projects is outlined in article 6(3) and (4) of the Habitats Directive, and its stated purpose is to provide a critical examination of the likelihood of significant individual and in-combination impacts upon the nature conservation objectives of European sites arising from the land use plan.

It is important to identify potential adverse impacts at an early stage in the development of plans and policies in order that any alterations necessary to ameliorate or mitigate impacts can be made.

There are four stages of HRA process. These are summarised below:

This report comprises the stage 1 – Screening of the Plan.

3) METHODOLOGY

This report is concerned with Stage 1, screening of European sites to identify and assess the likelihood and significance of impacts to these sites arising singularly from policies within the emerging Local Plan, and in combination with other plans and policies. The process for screening has involved the following steps:

- Identification of European sites within and outside the plan area that are potentially affected;
- The characteristics of these European sites and their conservation objectives;
- Assessment of likelihood and significance of impacts to European sites occurring as a result of the emerging Local Plan;
- In combination effects from other relevant plans or projects.

If significant impacts are considered likely, progression to Stage 2, Appropriate Assessment, is triggered.

4) OUTLINE OF EMERGING LOCAL PLAN

The emerging Local Plan will be the principal Local Plan document for Wyre Forest District. It will set out Wyre Forest District Council's spatial vision, strategic objectives, spatial strategy, policies and site allocations to guide future development and growth during the period up to 2036. This will include residential development (including Travellers and Travelling Showpeople Accommodation), retail and employment uses. It will also consider where new infrastructure will be required to support the anticipated developments (e.g. roads, schools, utilities, open spaces).

The emerging Local Plan has just completed its Preferred Options stage and work is now progressing on the Pre-Submission Plan. It is anticipated that the emerging Local Plan will be ready for submission in Winter 2018/19 with the Examination in Public commencing in early 2019.

Once adopted the Local Plan will provide the basis for determining planning applications. It will also allocate sites for development of housing, employment and mixed use schemes.

5) EVIDENCE GATHERING AND SCREENING

This HRA screening assessment examines the likely effects of the emerging Local Plan, either alone or in combination with other projects or plans, upon European sites. The HRA screening report for the adopted Core Strategy (adopted December 2010) concluded that no further work was necessary; however it is possible that the situation may have changed overtime and there will be new policies and site allocations in the emerging Local Plan. It is therefore necessary for the Council to undertake another screening assessment for the emerging Local Plan.

European Site Identification

Government guidance states that significant effects may be incurred even in cases where the area of the plan is some distance away. As a precautionary measure, this screening report has assessed to see if there are any European sites within 15km (straight line) of the District boundary. Information has been gathered from the Joint Nature Conservation Committee (JNCC) record as to the location of the European sites, their status and their reason for designation.

No European sites within the District boundary have been identified. However, there are two Special Areas of Conservation (SAC) sites within 15km of the District boundary. The first of these is Fens Pools SAC which is approximately 8.7km north of the District boundary and the second is Lyppard Grange Ponds SAC which is approximately 12.9km south of the District boundary. A map showing the location of the SAC sites and their proximity to the District boundary can be found in **Appendix 1** of this screening report. No SPA or Ramsar sites have been identified either within the District or within 15km of the District boundary.

The Characteristics of the European Sites identified

The following provides a summary of the European sites that have been identified outside of the District but within a 15km area around the District:

- <u>Fens Pools SAC</u> The site comprises of a series of small pools and a wide range of other habitats from swamp, fen and inundation communities to unimproved neutral and acidic grassland and scrub. Great crested newts Triturus cristatus occur as part of an important amphibian assemblage. The site, which shows evidence of post industrial activities, overlies Etruria marls and coal measures of the Carboniferous period;
- Lyppard Grange Ponds SAC This site can be found behind the community shopping area in Warndon Villages in the City of Worcester. The area serves as public open space within recently constructed housing and other built development. The SAC includes two field ponds located in the grounds of the former Lyppard Grange Farm. These two ponds, along with the surrounding terrestrial habitats, support a large breeding colony of great crested newts. The terrestrial habitat within these grounds now comprises rough grassland with brambles and scrub, and retains many mature native and exotic trees. Despite its small size, the site is very important for local wildlife as part of a network of nature conservation areas throughout the Villages and forms part of a Local Nature Reserve.

A map showing the location of the sites and their proximity to the District boundary can be found in **Appendix 1** of this Screening Report.

The conservation objectives of the European Sites identified

The table below shows the European Sites that could be affected by the emerging Local Plan. A detailed explanation of the conservation objectives is set out in **Appendix 2**.

6) ASSESSMENT OF LIKELY SIGNIFICANT EFFECTS

The emerging Local Plan sets out the District Council's intent to provide the future development and growth during the period up to 2036, as required by its OAHN. This future development and growth will be located on urban brownfield land and greenfield sites (some of which are Green Belt) within sustainable locations within the District.

Table 2 below provides an assessment of the likely significant effects the emerging Local Plan might have on the identified European sites.

7) <u>DEVELOPMENT NEEDS IN WYRE FOREST DISTRICT AND NEIGHBOURING LOCAL AUTHORITY</u> AREAS

The table below summarises the development needs in Wyre Forest District and neighbouring Local Authority areas that could also lead to 'in combination' impacts with Wyre Forest District emerging Local Plan.

8) <u>DETAILS OF OTHER PROJECTS AND PLANS</u>

The Habitats Directive requires Local Authorities to assess 'in-combination' effects alongside direct effects. 'In-combination' effects occur when otherwise non-significant proposals combine, and can cumulatively lead to a significant effect. This interaction can occur from proposals within the Development Plan or between the Development Plan and other projects and plans.

The table in Appendix 3 details the other projects and plans identified which may lead to incombination effects on the European sites.

9) CONCLUSIONS

There are two European sites (Natura 2000) within the 15km area around Wyre Forest District. The conclusions of these two sites are set out below:

Fens Pools SAC It is considered unlikely that the emerging Local Plan could have a significant effect on the Fens Pools SAC either alone or in combination. Plans in Wyre Forest will have no effect on human disturbance on this site which is already surrounded by development and easily accessed. The emerging Local Plan is unlikely to have any effect on protected species at or around this European site. Water quality is unlikely to be influenced by the emerging Local Plan since the site is already surrounded by residential development and road networks. The impacts on water supply are considered unlikely as there are no direct hydrological links between the site and the District. Due to the location of the site outside of Wyre Forest District and the fact that the emerging Local Plan process has no powers or influence over the future use of the site, it is considered that no significant effects are envisaged. Lyppard Grange It is considered unlikely that the emerging Local Plan could have a significant

effect on the Lyppard Grange Ponds SAC either alone or in combination. Plans in Wyre Forest will have no effect on human disturbance on this site which is already surrounded by development and easily accessed. The emerging Local Plan is unlikely to have any effect on protected species at or around this European site. Water quality is unlikely to be influenced by the emerging Local Plan since the site is already surrounded by residential development and road networks. The impacts on water supply are considered unlikely as there are no direct hydrological links between the site and the District. Due to the location of the site outside of Wyre Forest District and the fact that the emerging Local Plan process has no powers or influence over the future use of the site, it is considered that no significant effects are envisaged.

Due to the scale of growth envisaged within the District and the fact that the European sites identified are located some distance away, it is considered that no further appropriate assessment work is required for the emerging Local Plan.

In accordance with Habitats Regulations, this Stage 1 of the HRA has also completed an incombination assessment. None of the other projects and plans identified (see Section 8) will lead to likely significant effects on the European Sites in combination with the proposals contained in the emerging Local Plan, provided that any mitigation measures identified for other projects and plans are put in place.

In conclusion, the Stage 1 screening assessment has determined that the Wyre Forest District Local Plan Review (2016-2036) will not lead to likely significant effects, either alone or in combination, on the qualifying features of the European Sites.

It is therefore recommended that the Wyre Forest District Local Plan Review should not be subject to a detailed Habitats Regulations Assessment process. Should the Local Plan Review be changed or updated from that which is assessed in this document, then the HRA should be revisited.

10) NEXT STAGES

Consultation

This screening report is subject to a five week consultation with Natural England. Any responses from Natural England will be taken into account and this report will be reviewed and amended if necessary.

Emerging Local Plan

The District Council is currently preparing its publication Local Plan Review document. This will be published for a six week pre-submission consultation to be held during 2018. Following the pre-submission public consultation, the Local Plan Review submission document, together with any representations received, will be submitted to the Planning Inspectorate and will undergo an independent examination.
