NEIGHBOURHOOD PLAN

As you know, Chaddesley Corbett Parish Council have been awarded a Front Runner Grant of £20,000 to help towards the cost of preparing a Neighbourhood Plan.

The Parish of Chaddesley Corbett includes the Village, Drayton and Harvington and the Hamlets of Bellington, Bluntington, Brockencote, Cakebole, Hill Pool, Lower Chaddesley, Mustow Green (East), Tanwood, Winterfold, Woodrow and Bourne Green. Chaddesley Corbett is a large Parish of some 6,000 acres set within the hear of Worcestershire countryside and the Green Belt. The village itself is set within a Conservation Area, as is Harvington, and the outlying hamlets consist mainly of a number of properties in a rural setting surrounded by farmland. The hub of the Parish is the Village which contains St Cassians Church, a village school, two public houses, four shops and a surgery. When considering the area for a Neighbourhood Plan, it was felt that the whole of the Parish should be involved to avoid any overdevelopment of the village of Chaddesley Corbett itself. A map is attached showing the boundaries of the Parish.

Under section 61G of the 1990 Act, the Parish Council automatically qualifies as a suitable body to prepare a Neighbourhood Plan.


The first meeting of the Steering Group was held on 10 April 2012 and the next meeting is scheduled for 30 May 2012.


